The undersigned, being the _____ of land located within the above Public Water Supply District, hereby makes Application to said District
Owner or Tenant
for water service and agrees:

1. To become a water user of the District, I hereby tender \$ _____ as a water meter deposit and guarantee that my bills will be paid monthly, plus an additional \$ _____ per meter for meter setting and service line charge. The meter deposit will be refundable when service is discontinued and all charges and bills are paid;
2. To pay the monthly availability charge in the amount of \$ _____ per meter for the water service connection from the time service is made available by the District, whether or not water is being used, and to pay for additional water used at the rate set out in the rate schedule adopted by the Board of Directors. Any changes made in the minimum monthly water charge and rate schedule by the Board of Directors of the District shall become a part of this agreement as though fully set out herein;
3. The District will read meters on or about the 20th of each month after which bills will be mailed (typically within 3 days). The undersigned agrees to pay said bill upon receipt or before the 16th of the following month or be subject to a late charge as set out in the Rules & Regulations. Failure to pay a bill by the 28th of said month will result in discontinuance of service and additional fees charged pursuant to the Rules & Regulations;
4. The water service supplied by the District shall be for the sole use of the undersigned. The undersigned agrees that he/she will not extend or permit the extension of pipes for the purpose of transferring water from one property to another, and that he/she will not share, resale, or sub-meter water to any other consumer. Each meter service shall supply water service to only one residence or business establishment located on land within the District;
5. If after water service is made available, the same is discontinued or disconnected for any purpose, pursuant to the Bylaws and Rules and Regulations of the District, reconnection shall be upon the conditions set out in the Bylaws and the Rules and Regulations of the District;
6. The undersigned agrees that he/she will make no physical connection between any other water system (private well) and the water system of the District;
7. DAMAGE TO THE METER, INCLUDING THE RADIO READ EQUIPMENT WILL SUBJECT CUSTOMER TO A \$250 REPAIR CHARGE;
8. The laws of the State of Missouri, the Bylaws of the District, and the Rules and Regulations of the District, as presently existing, and as may be amended from time to time, are made a part of the agreement as though fully set out herein;
9. An application processing charge of \$ _____ will be retained by the water district.
